

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. ELIGIBILITY

The DeWALT® -JUMP START DIGITAL COMPRESSOR SWEEPSTAKES (the “Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Blue Collar Lists, and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. 3. SWEEPSTAKES PERIOD

The Sweepstakes begins on August 1st, 2020 at 12:01 AM Eastern Time (ET) and ends on August 31st, 2020 at 11:59 PM ET (“Sweepstakes Period”). One (1) drawing will be conducted and one (1) prize will be awarded to the potential winner of the Sweepstakes. Sponsor’s server and computer clock is the official time-keeping device and its decisions are final and binding. Results of the Sweepstakes are not official until Sponsor expressly announces the final results and verifies the winners.

4. HOW TO ENTER

During the Sweepstakes Period, log in to your Bluecollarlists.com account on a computer, wireless device, or through the Blue Collar Lists mobile application and visit the Rewards Page. Select the button associated with entry to win this prize utilizing your Blue Collar Rewards Points displayed on the rewards page. By selecting this option, users will be entered with one (1) entry into the Sweepstakes. Multiple entries are permitted. Normal Internet access, phone, and usage charges imposed by your online or phone service may apply. You may also enter by sending a 3x5 card complete with full name, address, email address, phone #, to Blue Collar Lists, LLC, JUMP, 114 R. Washington St., Marblehead, MA 01945. Limit one entry per stamped outer envelope. P.O. Boxes are not permitted. You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded. Automated or bulk entries or entries submitted by third parties will be disqualified. Entries must be submitted by the

contestant. Any attempt by any participant to obtain more than the stated number of plays and/or entries by using multiple and/or different identities, forms, registrations, email addresses, logins, or any other methods will void that participant's plays and/or entries, and that participant may be disqualified at Sponsor's discretion. 6. **SELECTION OF WINNERS AND ODDS OF WINNING:** On or around September 14th 2020, Sponsor, Prize Provider or either of their representatives will conduct a random drawing (the "Drawing") from all eligible entries to determine Potential Winner. Entries

are subject to verification and potential Winners are not declared final and shall not receive a prize until verified by Sponsor and/or Prize Provider. Sponsor's and/or Prize Provider's decisions are final and binding on all matters relating to this Sweepstakes. Odds of winning depend upon the total number of eligible entries received. All potential winner(s) shall be required to provide Sponsor and the Prize Provider with his or her name, physical mailing address, telephone number, email address and a valid photo ID (U.S. license, passport or similar proof of identity that is acceptable to Sponsor and/or Prize Provider in their sole discretion).
